9:15 AM	Responding to the Active Shooter – Run-Hide-Fight and A.L.i.C.E Rick Tustin  This presentation will provide an overview to all hazard planning for schools, businesses, health care facilities with an emphasis of preparing and responding to an Active Shooter and/or hostile intruder situation. Best practices as currently recommended by the Dept of Homeland Security Run Hide Fight protocol and the A.L.i.C.E. Institutes suggested protocol for responding to these types of threats.
	Presented by Captain Rick Tustin — Winchester Fire Department - 30 year veteran of the Department — Serves as the Town's Fire Prevention Officer — duties include engineering (design, plan review and approval), code enforcement and public fire and life safety education (Student Awareness of Fire Education programs and Middlesex County Juvenile Firesetters programs) and assists the Chief of the Department with Emergency Management preparedness and response initiatives. Serves as the Fire Dept co-chair for the Winchester Public School District Incident Management team and is a former member of the NEMLEC STARS team

	Global Harmonization System (GHS) Presentation- OSHA has issued a final rule to align its Hazard Communication Standard with the Globally Harmonized System of Chemical Classification and Labeling (GHS). The final compliance date for the revised Hazard Communication Standard (HCS) is June 1st, 2016. This is the date by which OSHA says employers must be in complete compliance - update alternative workplace labeling and hazard communication program as necessary, and provide additional employee training for newly identified physical or health hazards. This presentation will cover: Global Harmonization System (GHS) Overview, regulatory requirements, Key Terms, Labeling, Hazard and Precautionary Statements, Safety Data Sheets (SDS), and Training Requirements.
